Meeting frequency	Fortnightly and as and when required.
Terms of Reference	To determine all tenders with a value in excess of the limit set by Council from time to time. This includes a decision on reasonable grounds to not accept any tender and to re-tender the contract. To extend existing contracts for no longer than 12 months where the subcommittee is of the opinion that: <ul style="list-style-type: none"> • it is in Council's best interest to do so • The performance of the Contractor warrants such extension • The extension will not cause controversy or • The extension will not have legal implications for Council To recommend measures to the Operations and Capital Delivery Programme Committee on how to improve Council's oversight over the Council's staff's performance in managing contractors and contracts
Limits to Delegation.	Tenders must be awarded within available budgets. Council's Procurement Policy must be adhered to Where any tender award (or otherwise) may have legal implications or where a non-conforming tender is accepted, the reasons for decisions must be recorded.
