Special licence (for premises)

Sections 22, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Greymouth Golf Club -Incorp-** is authorised to sell and supply alcohol, on the premises situated at **113 Golf Links Road Kaiata** and known as Greymouth Golf Club Inc. to any person attending the following occasion or event (*or* series of occasions or events):

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 6 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

1. Alcohol may be sold under the licence only on the following days during the following hours:

- 2. The first floor, ground floor walkways, and the clearly defined outside putting green area are undesignated for the licence period and are shown on the plan attached to this licence.
- 3. A certified duty manager must be on duty at all times when the premises are open for the sale and supply of alcohol.
- 4. The licensee must take the following steps to ensure that the provisions of the Act relating to the sale or supply of alcohol to prohibited persons are observed:
 - Minors and intoxicated persons must not be served alcohol.
- 5. The licensee must display signage as follows:
 - a. A sign at each principal entrance to the premises, so as to be easily read by patrons, stating the ordinary hours of business during which the premises will be open for the sale of alcohol;
 - b. At every point of sale detailing restriction on the sale and supply of alcohol to minors and intoxicated persons;
 - c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises and;
 - d. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 6. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcoholic beverages.

Heart of the West Coast

- 7. Food, as listed by the applicant must be available for consumption on the premises during the licence hours.
- 8. Drinking water is to be provided free of charge from a water supply prominently situated on the premises.
- 9. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 10. Noise levels are to be monitored at all times.
- 11. Payment of the fee prescribed under the Sale and Supply of Alcohol (Fees) Regulations 2013.

The premises licensed area is set out on the plan submitted with the application and date stamped 3 December 2024.
