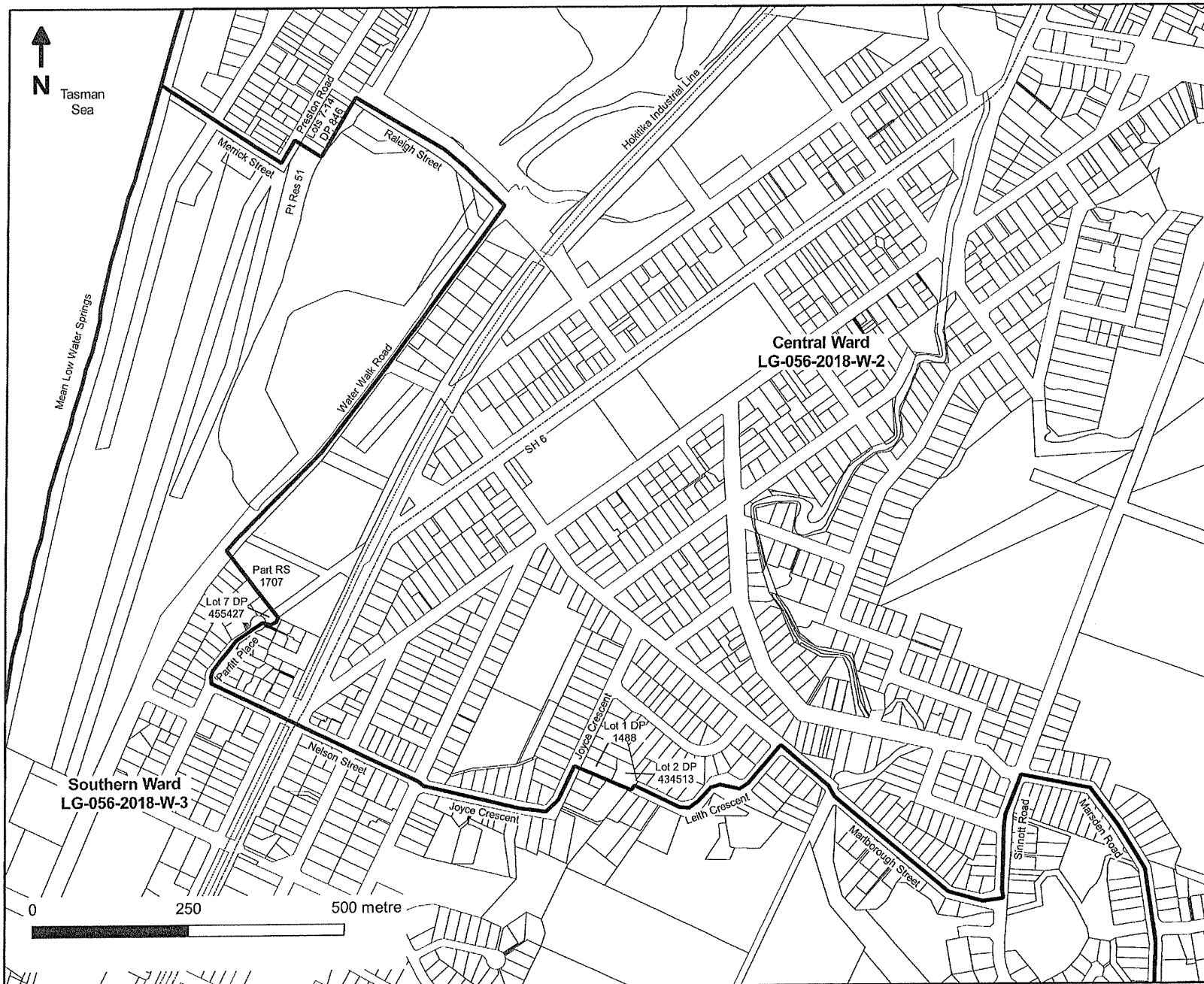

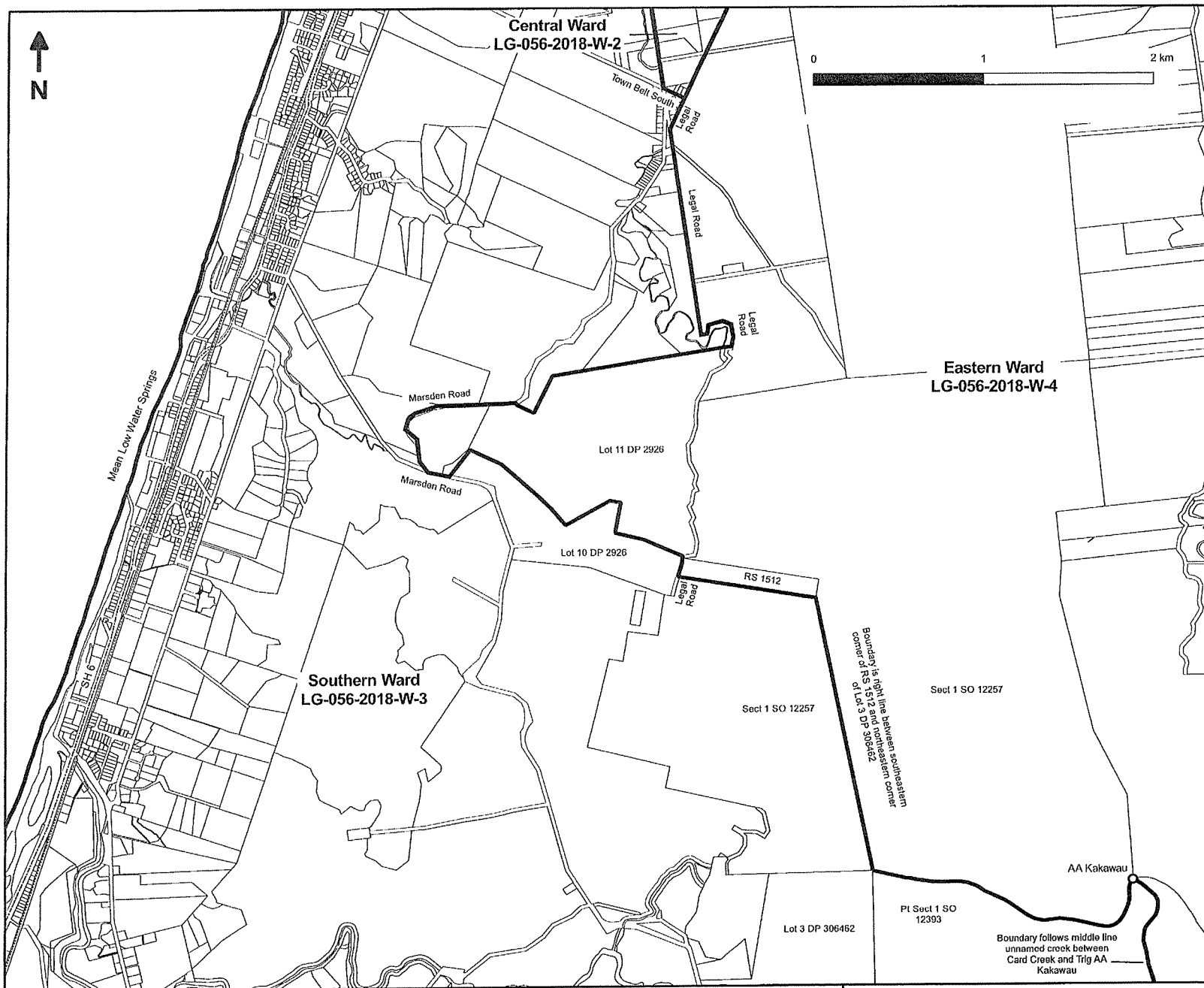

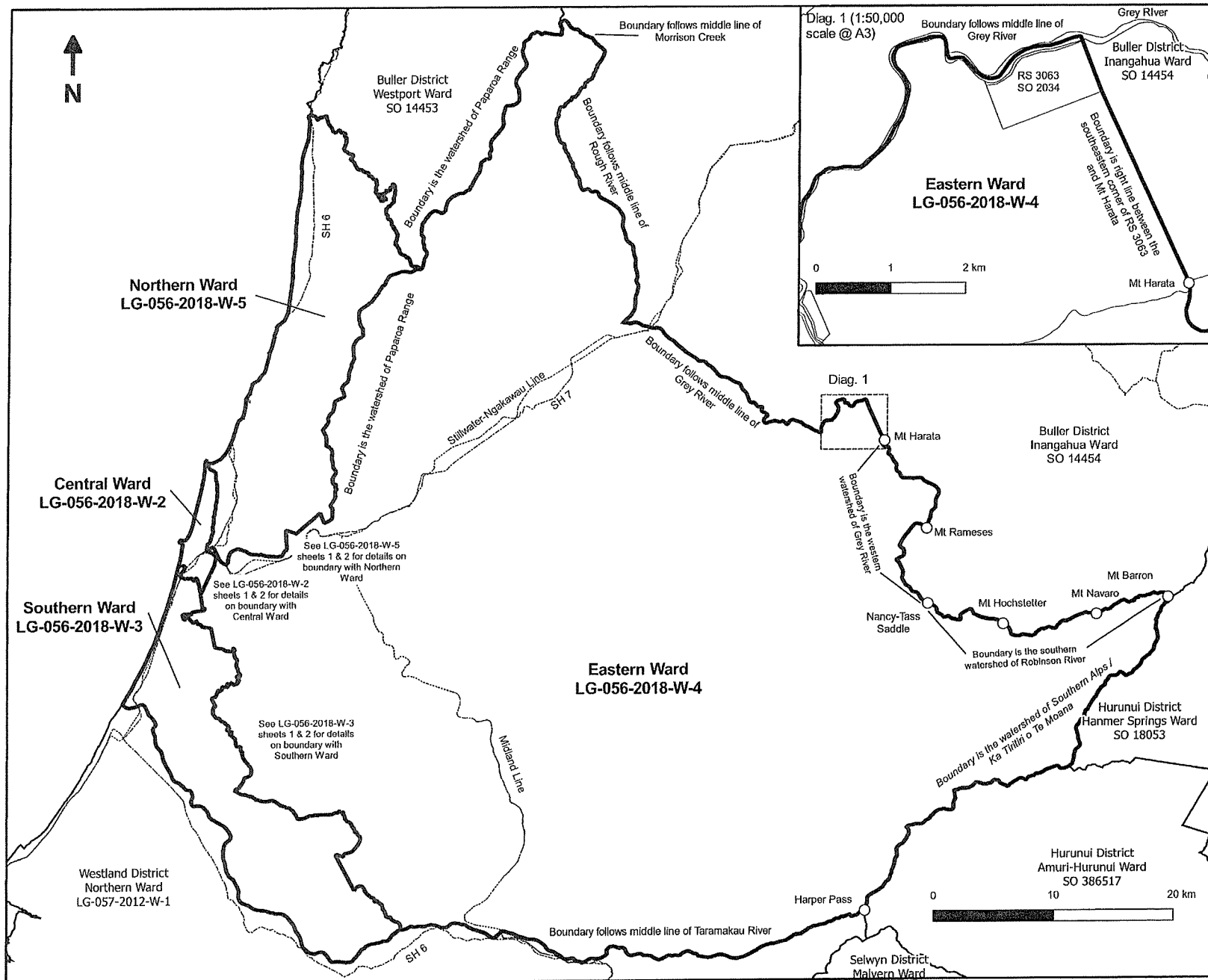

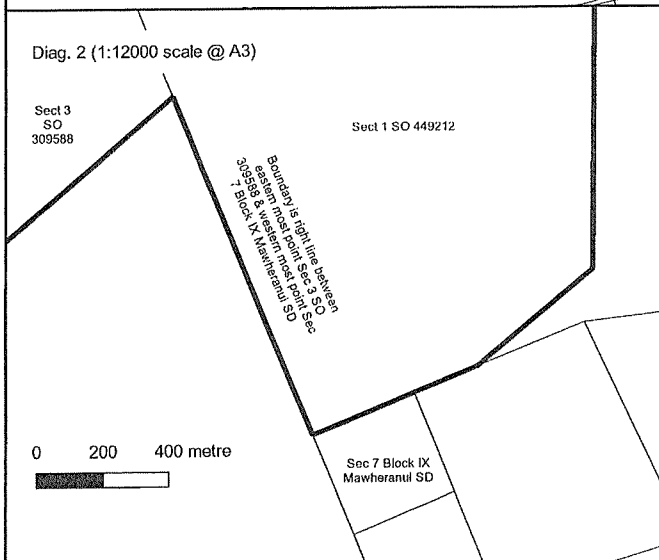
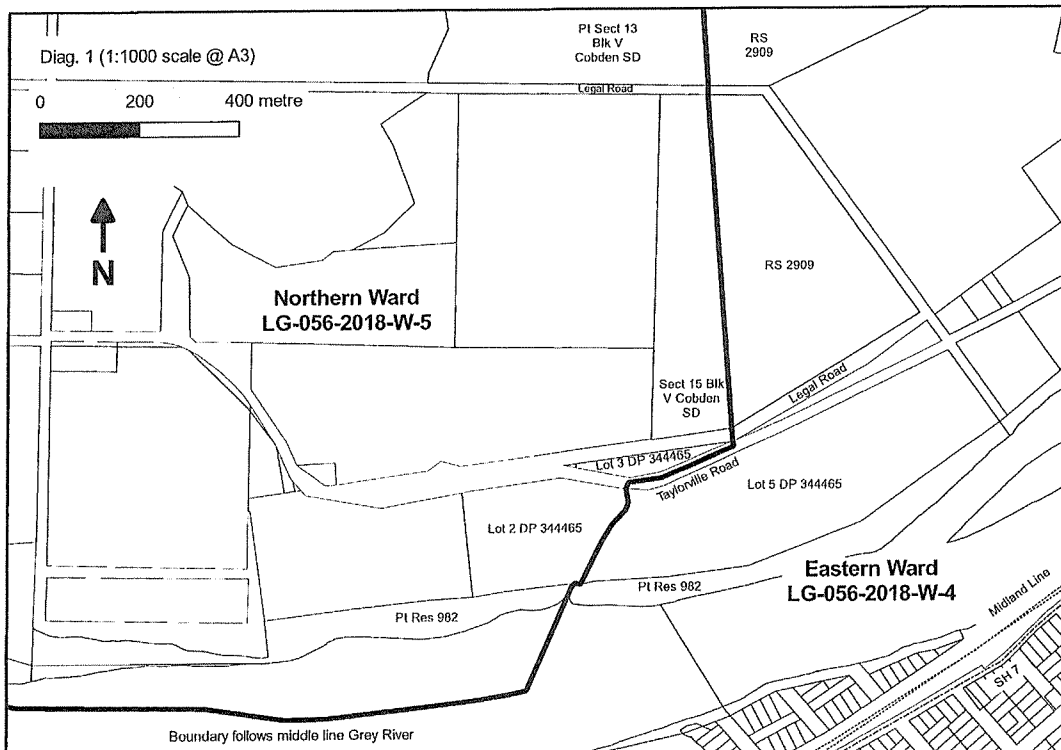
Grey District Eastern Ward

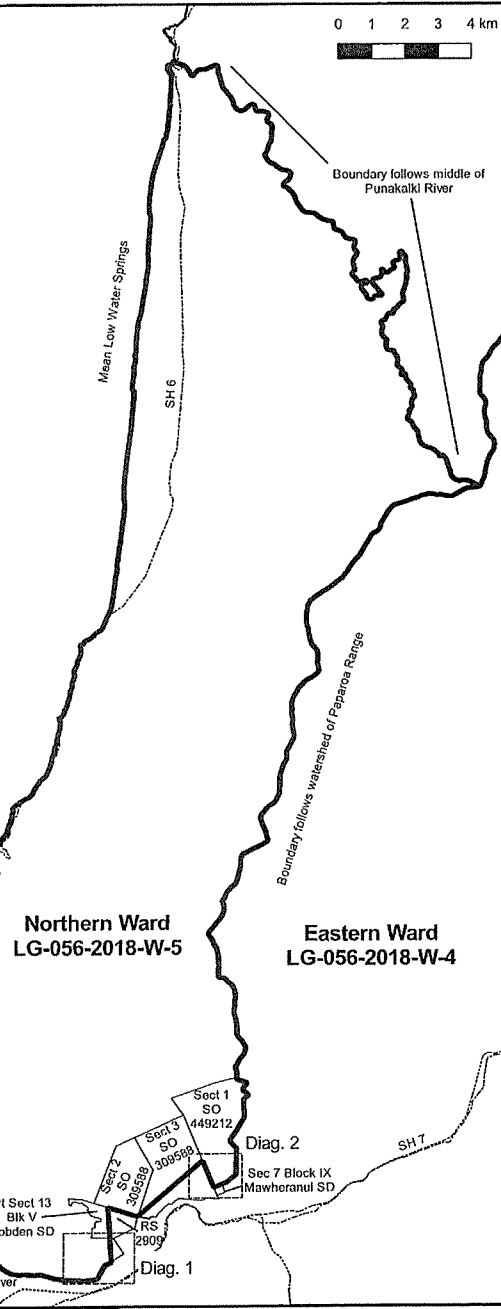
