- The Director General of Conservation's submission will be heard on 26 February 2024 by AVL, and the Director-General is asked to do the following:
 - (a) Arrange for Ms Simister to review the evidence given by witnesses on the Westland Petrel, including that of Dr Susan Waugh and Mr Stuart-Menteath.
 - (b) Ask Ms Simister to liaise with Mr Stuart-Menteath concerning his proposed conditions to address the verbal submission dated 8 February 2024.
 - (c) Liaise on 21 February 2024 with Rasela Barrow and arrange a time for that AVL hearing.
- We ask that Ms Barrow give the Panel and parties the relevant details to connect to that AVL hearing as soon as possible.
- We direct Mr Harding and the Council planners to provide updated hearing statements on matters arising from the hearing by 1 March 2024.
- We ask the Applicant to provide their reply submissions and evidence by 7 March 2024.
- We will conduct a resumed hearing in the week commencing 11 March 2024, either by AVL or in person, with the details confirmed by a separate Minute.

- Throughout this continuing process, despite any recommendations, we ask the planners to confer about the appropriate conditions in light of the evidence that should apply to the activity if the Panel gets to the position that consent should be granted.
