Forest & Bird opposes this consent application in its entirety for the following reasons:

1. The activity will likely have adverse effects on indigenous vegetation and habitat for indigenous fauna, on the natural landscape, and on freshwater ecosystems and the coastal marine area, and the native species that live in these environments, and the native species that use the area and its surrounds to breed and feed.

- 2. Forest & Bird is the owner of the 27-hectare Dick Jackson Memorial Reserve, located south of Punakaiki and surrounded by the Paparoa National Park and Te Ara Taiko Nature Reserve. The Dick Jackson Memorial Reserve is a native forested reserve which is home to the Westland Black petrel and ecologically, is connected to a larger reserve that is the world's only breeding area for the Westland Black petrel. This site is of global significance. Considering this site's global significance there is a strong imperative to ensure that it is protected from any and all harmful effects.
- 3. While we acknowledge that the mining activity may have economic benefits to the West Coast region, we are concerned that these benefits will not outweigh the potentially adverse economic and social effects on the local community and the nature-based economic activities, particularly those that have established in the area as a result of the Paparoa National Park and other protected natural areas in the West Coast region.
- 4. The activity is inconsistent with:
 - The New Zealand Coastal Policy Statement 2010
 - The National Policy Statement for Indigenous Biodiversity 2023
 - The National Policy Statement for Freshwater Management 2020
 - The Resource Management Act 1991, specifically part 2 sections 5, 6a-c and potentially d, and 7
 - The West Coast Regional Policy Statement, specifically Chapters 7, 7A, 7B, 8, 9, and 11.
 - The Grey District Plan and the proposed Te Tai o Poutini One Plan
- 5. The proposal seems to be at odds with Te Whanaketanga Te Tai Poutini West Coast Strategy 2050, which has a key aim of improving the wellbeing of ALL Coasters.
- 6. Forest & Bird also considers that the activity is inconsistent with Aotearoa New Zealand's Emissions Reduction Plan as required by the Climate Change Response Act 2002.

Forest & Bird seeks that these resources consents are **<u>DECLINED</u>** in there entirety.
