Note to submitter

If you are making a submission to the Environmental Protection Authority, you should use form 16B.

The closing date for serving submissions on the consent authority is the 20th working day after the date on which public or limited notification is given. If the application is subject to limited notification, the consent authority may adopt an earlier closing date for submissions once the consent authority receives responses from all affected persons.

Over time, the West Coast is facing rising sea levels. Mining in this manner could hasten this, potentially contributing towards a disastrous effect in the Barrytown region. In the nearer future, the local bird life and waterways, which are fragile systems, may not thrive with the mining, and because this hasn't been done around them before, any promises that 'all will be well' are just conjecture at this stage.

As a Coast Road resident, I am impacted by the light and noise of every truck that passes our home. To have this increased through the mining will greatly impact quality of life, in an area known to be full of natural beauty. This would also impact the many other local residents in the area, as well as tourists who come here for the views, the peace and connection with nature. Seeing mining trucks and indeed, a mine, does not fit in with what this area is world renown for.

When we built our house on Coast Road, we had to pass different consents and pay their associated fees regarding the minimisation of our building's impact in this area of natural beauty. For example, providing landscaping plans, set colour schemes, etc. We were happy to do so, being conscious that this is an area to be enjoyed by all and we don't want our house to take away from that. Entertaining the idea of placing a mine in this same area is ludicrous. What is the point of asking residents to follow strict guidelines to minimise their human impact here, while at the same time allowing 50 mining trucks to use this stretch of road a day? How is that minimising the human impact in this area?

Open cast mining will generate a significant amount of dust. The discharge permit allows dust to be discharged to the air without any restrictions. In an area with predominantly North-Westerly and South-Westerly winds, this means the dust will be blowing inland, right where many Coast Road residents live to the north and south of the proposed mine site. Is there any mechanism in place to monitor and mitigate the hazardous effects of this?

After living in the area for over 5 years and travelling Coast Road regularly for work and leisure, it was very easy to see the detrimental effects of increased traffic prior to and after the Covid travel restrictions. The road also requires numerous repair jobs after stormy weather, with slips especially. Most of the time, the repairs are patchy and not a long term solution, particularly with the expected increase in visitor numbers over summer months. Already, for a State Highway, the road is not in good shape, and that has easily been observed and commented on by foreign visitors I have met. Now that I live along the Coast Road, I see the degradation in certain areas, despite the repairs they get. Having 50 heavy trucks and potentially 130 more cars travel this route daily is pushing the capacity of this already strained road. How is the council going to maintain this lifeline, which is bound to fall into greater disrepair with this increased use?

In the past year, we have seen a large number of people moving to the Coast. Part of the appeal here is the pristine nature - in fact, this is also why my wife and I chose to make our home here. The argument that this mine would provide jobs and benefit the local economy pales when compared to the potential loss of income from declining tourism. Nobody likes to travel behind a truck. Nobody wants to see a mine. Nobody wants to breathe dust.

The West Coast might as well change its tagline from 'Untamed Natural Wilderness' to 'Show Us Your Money And We'll Let You Do Anything' if this proposal is allowed to go ahead.
