- 4. It is evident that the proposed heavy trucking operations pose significant risks, not only to infrastructure but also to the safety and tranquillity of communities along SH6. Our concern extends to the safety of schoolchildren, cyclists, pedestrians, and tourists, as we believe that all people, no matter where they are, deserve to navigate our roads without added danger.
- 5. Our profound appreciation for the current amenity values of the affected areas draws us to protect them. We recognise that these values attract visitors and residents alike, and the proposal if approved, would undoubtedly diminish the natural beauty of our coastal environment, erode the social bonds of communities, and diminish the recreational experiences we hold dear.
- 6. Our genuine concern for the well-being of the Westland petrels, the Tāiko, is a reflection of our commitment to the broader ecosystem. We recognise the potential for devastating cumulative effects from the proposed mining and trucking activities, particularly during the darkness hours, which could create dangerous light distractions for these already threatened birds.
- 7. The heavy use of fossil-fueled machinery and trucking associated with this project deeply troubles us due to its contribution to carbon emissions. We firmly believe that our responsibility to combat climate change goes hand in hand with protecting the environment.
- 8. It is disheartening to see a proposal that appears to contradict the West Coast Regional Council's "Untamed Natural Wilderness" strategy, which prioritizes the preservation of our natural environment. Furthermore, we worry about the negative impact on local nature tourism operators and accommodation providers, who are essential stakeholders in our shared commitment to environmental preservation.
- 9. The potential hazards of radiation and the absence of a New Zealand code of practice for managing radiation safety in the mining industry are deeply concerning to us, as they raise questions about the long-term consequences for both local and broader ecosystems.

10. We firmly believe that the proposal contradicts the principles of the Resource Management Act, as well as numerous national, regional, and district-level objectives and policies that have been put in place to safeguard our environment. Our shared commitment to environmental protection drives our opposition to a project that runs counter to these vital principles and safeguards.
