| I oppose the application due to adverse effects on indigenous flora and fauna, incl. Westland Petrel. The proposed mining operation poses a potential unacceptable cumulative effect on the petrel population. Exposed lighting and noise is a real threat to the birds, especially fledglings, who become distracted and get stranded. Once they are on the ground they need to be re-launched. A few deaths has a significant effect on the breeding population with a notably slow reproductive rate. The survival of the Westland petrel has great significance as these birds are the last remnant of a unique ecosystem. They are one of the few petrel species that remain on the mainland of New Zealand and inhabit much of the same breeding range on the West Coast of the South island as they did before humans arrived. The Westland petrel is at risk and their only breeding colonies are on the Westcoast/Punakaiki. They do not breed anywhere else in the world!!! and are endemic and unique to New Zealand. The proposal is inconsistent with the requirement of Policy 11 of the New Zealand Coastal Policy Statment (NZCPS) to avoid adverse effects on threatened or at-risk indigenous species and their habitats. | | | | | |
