### Submission

# I oppose the application due to:

It is with deep regret that I have discovered the proposal to mine the exceptional environment of biodiversity and scenic beauty, of the Barrytown Flats.

We first discovered the Barrytown Flats during a grand tour of the south island of New Zealand back in December 2018. We were circumnavigating the south island starting in Christchurch, traveling clockwise. The journey traveling north up the west coast highway, from Haast to Westport was planned to give us a break from the hustle and bustle of more touristy parts of the island.

As we travelled just north of Greymouth we noticed the landscape changing, especially as we traversed the hairpin bend in the road at Nine Mile Lookout. We had a marvellous view of the unspoilt seascape of Barrytown Flats. The plateau that interfaces the Tasmin sea to the Paparoa Mountains in all its splendour with waves lapping the coastline, it was truly magical.

We spent three days in the area exploring the coastline, trekking on part of the Paparoa Track, and enjoying the tranquil atmosphere that not only we were enjoying, but also the abundant birdlife in the area obviously were too.

If this proposed mine goes ahead, I think it will be a very sad indictment, not only for the residents and wildlife, but for New Zealand as whole. As a British citizen, we view New Zealand as a pioneering environmentally, ecologically sensitive nation, proud of its heritage. A big part of this is highlighted by the movement to eradicate all non-native predators, to allow the native ecological system to thrive.

The proposal for this mine appears to go completely against the grain of this ethos. Raping the Barrytown Flats of the natural resources will have an extreme effect on the environmentally legacy for the area.

My partner and I plan to visit New Zealand in the future and spend more time on the west coast on this return visit. If the mine goes ahead, we will be cancelling this trip. This would be a trip that would not only benefit the west coast region, but New Zealand in whole (our budget for the trip would be 10,000 NZD). We would also boycott our love of New Zealand wines which we currently spend 10's NZD on per month.

We urge the decision makers to deeply consider the effect the proposed mine will have on revenue generated from tourism, not only in the Barrytown area, but New Zealand as a whole, especially when its reputation becomes tarnished as no longer being an environmentally/ecologically friendly destination.

I seek the following decision from the Local Authority: that the application be declined in its entirety.
